### What is Corporate Matching?

- Corporate matching happens when companies financially match the donations that their employees make to nonprofits.
- An employee must notify their employer after the gift has been made, and requests a matching gift form from their employer, who then makes a matched gift.
- Most companies have a corporate matching program, and will match an employee's donation dollar for dollar, or more.

# How do I know if my company has a match giving program?

- 1. Use this webpage (https://ww2.matchinggifts.com/search/unh) to see if your company is registered for corporate matching.
  - · Follow the steps to share with your employer.
- 2. You can also make your donation directly to the Operation Holiday Impact giving link, found on our website: operationimpact.co
  - You will see an option for matching to verify your work email and/or company is eligible for matching.
  - If so, a notification will be emailed to you for next steps in order to complete match request.
